## Case of the Month

### I. Eminent Domain – Caltrans’ Exit before the Last Offramp

Sharon D. Dina et al. v. The People ex rel. Dept. of Trans.(Caltrans)  
Filed June 5, 2007, Second Appellate District, Division Two  
( Cite as 2007 SOS 3007)

Caltrans successfully avoided several jury trials by pursuing motions to dismiss causes of actions brought by property owners alleging inverse condemnation, nuisance and negligence. Caltrans’ motions to dismiss, pre-jury trial, were based upon Code of Civil Procedure section 1260.040.

“Property Owners” Sharon Dina and David & Joann Whiteley, appealed a trial court’s judgment entered in favor of Caltrans. Property Owners brought separate complaints alleging inverse condemnation, nuisance and negligence by reason of noise, vibration, air pollution and property damage they claimed to have suffered as a result of the extension of the I-210 Freeway adjacent to their residences. After the case had been pending for one and one-half years and before starting a jury trial, Caltrans moved to dismiss pursuant to Code of Civil Procedure section 1260.040, which permits parties in an eminent domain proceeding to move for a ruling when “there is a dispute between plaintiff and defendant over an evidentiary or other legal issue affecting the determination of compensation . . . .” (Code Civ. Proc., § 1260.040, subd. (a)). Caltrans’ motions requested that the trial court evaluate whether Caltrans was legally liable for inverse condemnation, nuisance and negligence, prior to a jury deciding the issue of just compensation.

At the motions to dismiss and considering the Property Owners’ opposition, the trial court found that the Property Owners failed to offer evidence supporting a statutory basis for their cause of action for negligence.

The court found that the alleged “nuisance” conditions of which Property Owners complained were obnoxious to all persons who lived in close proximity to the state’s freeways, but that the alleged conditions must be endured without redress. The trial court also determined that Property Owners’ did not present any evidence that the freeway was constructed improperly. Thus, the nuisance claims fail as a matter of law.

Finally, the trial court agreed with Caltrans that the Property Owners failed to demonstrate by a preponderance of the evidence that their properties suffered peculiar and substantial damage or that the freeway construction or its operation were unreasonable. Caltrans was found not liable to Property Owners for inverse condemnation.

The Property Owners’ cases were dismissed by the trial court and judgment entered for Caltrans. The Property Owners appealed the judgment.

The Property Owners challenged the judgment on the ground that C.C.P. section 1260.040 didn’t authorize the trial court to resolve the entire action and, in particular, didn’t permit the trial court to weigh evidence. Property Owners further contended that even if section 1260.040 could have been employed in the manner utilized by the trial court, substantial evidence didn’t support the trial court’s determination. The appellate court disagreed with the Property Owners on both issues.

The appellate court determined that the language and legislative history of section 1260.040 permits a trial court to resolve legal issues, including liability. Therefore, the trial court could find that the Property Owners did not have sufficient grounds for maintaining their causes of action for inverse condemnation, nuisance and negligence, forestalling the need for a jury trial determining just compensation.

The appellate court affirmed the trial court judgment for Caltrans, Caltrans avoiding a jury trial to determine the issue of just compensation. Caltrans was awarded its costs on the appeal.

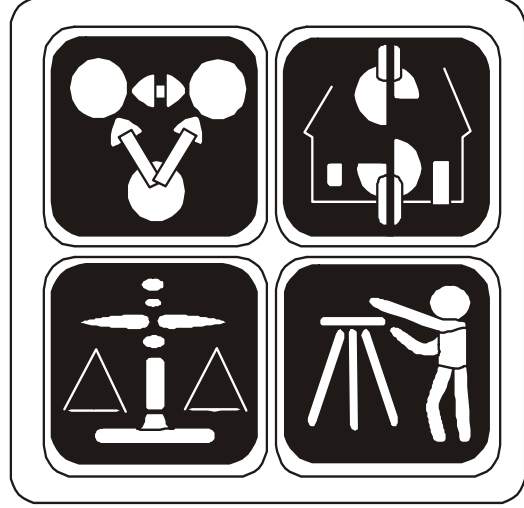

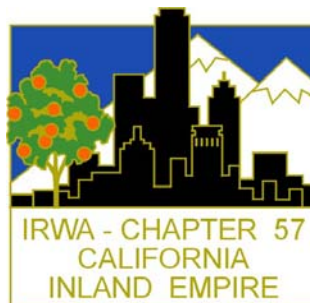
